

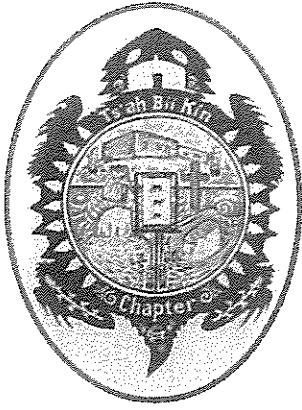
Meetings will be scheduled on the first and second Monday's of each month, with the exceptions of all recognized Holidays where meetings will be the following Tuesday.

APPROVING AND SUPPORTING PLANNING MEETING AND REGULAR CHAPTER MEETING SCHEDULE FOR THE REMAINDER OF THE 2022 FISCAL YEAR; TO HAVE PLANNING MEETINGS ON THE FIRST MONDAYS OF THE MONTH AND THE REGULAR CHAPTER MEETINGS ON THE SECOND MONDAYS OF THE MONTH

WHEREAS:

1. Pursuant to N.N.C., Section 3 (A), the Ts'ah Bii Kin Chapter is a duly recognized certified chapter of the Navajo Nation Government, as listed at 11 N.N.C., part 1, section 10; and vested with the authority to discuss all matters affecting the Navajo people and its Nation; and
2. Pursuant to N.N.C., Section 1 (B), the Ts'ah Bii Kin Chapter is vested with the authority to review all matters affecting the community, make appropriate corrections when necessary, and provide recommendations to the Navajo Nation and other local agencies for appropriate action(s); and
3. The Ts'ah Bii Kin Chapter approves and supports to have each planning meeting on the first Mondays of the month and each regular chapter meeting on the second Mondays of the month, and;
4. The Ts'ah Bii Kin Chapter shall abide by such scheduling for the remainder of the 2022 fiscal year, and;
5. The Ts'ah Bii Kin Chapter shall adopt by resolution a meeting schedule and abide by such schedule for each fiscal year starting in September.

NOW THEREFORE BE IT RESOLVED THAT:

The Ts'ah Bii' Kin Chapter hereby approves and supports the scheduling of each planning meeting to be held on the first Mondays of each month and the regular chapter meetings to be held on the second Mondays of each month for the remainder of fiscal year 2022. That the Chapter shall adopt each meeting schedule by September for each fiscal year here after.
